# Report on the 2017 Mershon Annual Meeting and Reunion

The 2017 annual meeting of the Association of the Descendants of Henry Mershon was called to order on Saturday, July 22nd, at 10:15 am in the Community Meeting Room at the Lawrence Headquarters Branch of the Mercer County Library in Lawrenceville, NJ. Reverend Phillip Mershon led us in an invocation, followed by a spirited rendition of the Star-Spangled Banner on his saxophone. We gave the Pledge of Allegiance. Each family group introduced themselves and shared information about their family history.

At 11:00 am, Laura Nawrocik of the Mercer County Library Staff updated us on what is happening with the Mershon archives, now part of the Lawrence Township Archives. She explained plans to digitize more information. Following Laura's presentation, we continued with family introductions until 12:00 pm, when we set up for our catered box lunch meal. As a special treat at the end of lunch, Phillip Mershon played a jazzy version of "Summertime" from the musical <u>Porgy and Bess</u>.

#### Living history program on Abraham Lincoln, after lunch -

President Lincoln was portrayed by re-enactor Bob Gleason of the American Historical Theater in Philadelphia. From humble beginnings, Abraham Lincoln led our nation through the most difficult period in our American history. Lincoln had only about one-year total of formal schooling while growing up, often interrupted by the need to help support his family. He had a burning ambition to learn, so he read books, whenever he could, to educate himself.

It was a fascinating 80 minutes of Lincoln antidotes with some quotes from his speeches. Bob Gleason stayed very much in Lincoln character, displaying good humor and connecting well with our audience. "Mr. Lincoln" even referred to his unfortunate assassination in 1865. We had an opportunity to ask questions at the end of his program. As he departed, each member of our audience received a "Presidential Pardon."

**Mershon Southern Chapter Report**: The Southern Chapter met on May 19 & 20, 2017 in Pigeon Forge, Tennessee (see page 5 for their report).

**Executive Board Report**: The Executive Board met on Friday evening July 21<sup>st</sup>. Main items considered were-

- Harrison Hunt resigned in June 2017 as our News Bulletin Editor, but will continue on our Executive Board. Linda Hunt resigned in June 2017 from our Executive Board. David Beun is resigning as our Vice President, effective at the end of 2017.
- Noel Barton is nearing the end of his paid work organizing and digitizing our Mershon archives
- Harrison Hunt is waiting for advice from an attorney on our IRS 501(c)3 non-profit application.

- We discussed moving our Mershon Association annual meeting to other cities or sites besides Lawrenceville, perhaps in one year out of three. We would need a core group of persons on-site or familiar with the site to make the meeting arrangements. It was decided that our Executive Board will consider proposals for holding our Mershon annual meeting in a different location, potentially starting with our 2019 Mershon annual meeting.
- We discussed the pros and cons of applying for free history programs offered by the New Jersey Council for the Humanities to non-profit organizations. We would need to advertise the programs as open to the general public because the Council policy requires that the general public be invited.
- We reviewed a proposed slate of nominations for our 2018 Mershon Association officers.

## Report on the 2017 Mershon Association Southern Chapter Reunion May 19 & 20, 2017 - Pigeon Forge, TN

A family dinner was enjoyed at the Old Mill Pottery restaurant on Friday evening, 5/19.

The family meeting was held on Saturday morning, 5/20. The meeting called to order at 9:00 am by Acting President Wally Riviere. Chaplain Glenn Roberts gave an invocation and led the pledge of allegiance to the American flag.

Wally Riviere gave a historical accounting of our forefather Henri Mershon's migration to America from France in circa 1680. The reason for migration being religious persecutions in France under King Louis XIV. Earlier French settlers had arrived in 1562 at what they named "Paris Island" and establishing the first European Settlement of "Charlesfort" near present day Beaufort, SC.

We had an attendance of 13 people and a renewed interest in the Association. Ann Roberts was thanked for being this year's hostess.

A discussion about the future of this Association was led by Wally. It was decided that we will continue for another year as in the past. New officers were elected as follows: President Glenn Roberts; V-President Larry Morton; Corresponding Secretary Ann Roberts; Treasurer Wally Riviere; Recording Secretary open (a recorder will be appointed by the president at each meeting to make notes and prepare minutes); Chaplain Glenn Roberts.

## Henry Mershon IV Jar Donated to Mershon Association

The jar "...has been moved from pillar to post and it's amazing it's still here and intact," so said Henry Mershon IV descendant, Virginia Skillman, as she donated her redware jar to our Mershon Association.

Ruth Conover, an administrative assistant at the Presbyterian Church of Lawrenceville (PCOL), contacted me in mid-January 2018 saying a woman named Ana Bkir, who works for a woman named Virginia Skillman (Ana is her nurse's aide), came into the church office. Ruth said Virginia is 90+ years old and has a jar that has some connection to the Mershon family. Because of her age (she is actually 96), Virginia wished to donate the jar to our Mershon Association.

I phoned Ana, who in turn put me in touch with Virginia, who said the artifact was a clay vessel, about 10" in height, which belonged to Henry Mershon IV and was handed down to her through the family. According to the late Winona Nash, Henry's stone farmhouse, later known as the Marroe Inn, was located due east of the Lawrence Headquarters Branch of the Mercer County Library, between Alternate US Highway 1 and the Delaware Raritan Canal (see a drawing of the Henry IV house in our March 2017 News Bulletin, page 6).

Virginia said the vessel is in good shape. At that point, I made arrangements to call in on Virginia at the Stonebridge Assisted Living facility just north of Princeton in Skillman, NJ.

My wife Lauren and our youngest son Thomas, both of whom are descended from the Andrew<sup>3</sup> line, went with me to Skillman to collect the Mershon artifact. We had a pleasant visit. Virginia was in full possession of her mental faculties and was quite pleasant. However, she did not want her picture taken. The vessel passed from Henry IV (1740 - 1815) to his daughter Abigail, to Mary Anne Lee, to Minnie May Coleman (b. 1872), to Grace A. Pierson and finally to Virginia.

Virginia and her husband, who was a lawyer, settled in the small village of Griggstown, NJ, during the 1960's. She said they made their living flipping houses. Her interest in local history began when her mother-in-law was forming the Hopewell chapter of the DAR. She is the only female left on both sides of her tree and thus ended up with some family artifacts. She says the vessel was last used on the Pierson Farm on Cold Soil Road in Lawrence Township. Minnie May and Lewis Pierson sold that farm (they moved to Craven Lane) to AT&T and it became known locally as the "pole farm." It is now a passive use county park.






The jar has been turned over to Dennis Waters, representing the Lawrence Township Archives, where our Mershon Association archives now reside. Before putting the jar on display at the Lawrence Township offices, Dennis had the jar evaluated by pottery experts at Hunter Research in Trenton. They suggested the jar be described as follows -

"Lidded Storage Jar, 19th century Redware, lead-glazed with footed base, tooled shoulder and tapered neck. Unmarked on base. Probable production by the McCully Pottery, Trenton, NJ (8" High, 5.75" Dia.)"

Hunter Research says "... The McCullys' established potteries in Trenton as early as 1783 and more permanently in 1799. Production by the McCullys' continued into the 1860s."

Virginia also conveyed a 1913 PCOL cook book to me, which I passed on to the church office as requested by Virginia. The book had a recipe submitted by Mrs. C. S. Mershon and two recipes submitted by Mrs. James Stevens, second wife of the third Mr. Stevens to own our O'Neal home in Lawrenceville. Ruth Conover and the PCOL office manager had a good time looking over the old recipes. The book will be passed along to our church historian.

Orange Cream Pie.—Beat thoroughly the yolks of 2 eggs with ½ cup of sugar. Add 1 heaping tablespoon of flour, 1 even tablespoon of cornstarch dissolved in milk. Pour into 1 pint of boiling milk and let cook about 3 minutes; let cool, flavor with extract of orange and pour into a baked crust. Put meringue on top.

# Bernice Mershon, Opera Singer, made news in 1930

"Wife says She stole Husband's Love – Wants \$50,000" by Clare Mershon, Portland, OR

You may recall the article about Bernice<sup>7</sup> Mershon, Opera Singer, authored by Lisa Roose-Church in our June 2011 Mershon News Bulletin and a follow-up article in our December 2014 Bulletin. "New York – Miss Bernice Mershon, Light Opera Contralto, has been named in a \$50,000 suit brought by Mrs. Tessie Gerber, in which it is charged that the former rewarded Mr. Gerber with kisses when he collected rent for her on a building she owned. Mr. Aimé Gerber is Paymaster of the Metropolitan Opera Company." (Dated June 6, 1930)

Bernice, born in 1884, was a well-known singer during the early part of the 20<sup>th</sup> Century. She sang 30 grand opera roles in the U.S., Italy and France; performed light opera as Eddie Cantor's prima donna and became established as a Gilbert & Sullivan artist. Bernice performed in five shows on Broadway. At the time of this June 1930 photograph, she was playing Gladys Carroll in *Fifty Million Frenchmen*.

The outcome of this suit is unknown, but Mr. and Mrs. Gerber were still married in 1940, according to the U.S. Census. Bernice probably found another way to collect the rent on her building! With the "lawyers bookcase" on the right side of this photograph, Bernice may have been in her attorney's office when this photograph was taken. According to Google, \$50,000 in 1930 would be equivalent in purchasing power to \$742,000 in 2018.

Bernice retired from the stage in 1932, making her home in Los Angeles, where she died in 1960 at age 76. She was married three times, but had no children. Bernice was a Thomas<sup>3</sup> Mershon descendant.
